All children across the school from Reception to year 2 have access to the extra-curricular activities. 2. Successful use of the School Sports Partnership. All KS1 children accessed the offer with the vast majority (96%) taking part in inter-sports activities. 3. Good use of TAs at lunchtime to encourage children to participate in active lunchtimes. 4. Swimming lessons started for Year 2 children which was a great success, however this was disrupted due to COVID-19 and now has been hindered by swimming pool maintenance issues. 5.
